## 2021Golf Packages Details

### Regulars Packages (10, 25 and 50):

- Max 3 Beneficiary's (only 1 can be non-family member)
- Regular (or Beneficiary) must be present with all guests using credits
- 25% off on all FVR Merch for Regulars and Beneficiaries
- Cart and range balls are included with each round
- Option for 2021 Practice Facility Package
- USGA HDCP Annual Registration
- Free Ride Companion
- 9-hole play option
- Good for 2 years

#### **Partner Packages:**

- Max 3 Beneficiary's (all Beneficiaries must be an employee or representative of Company listed)
- Payment can be split to 50% upfront and 50% on 4/1/21 or when 1/2 credits have been used, whichever comes first
- A Company Employee or Representative must make the original tee times for their guests
- Cart and range balls are included with each round
- No partial credit will be given for incomplete round (charged for 18-hole credit) unless rain
- Only Company Regular and Beneficiaries listed on Partner Package are eligible for:
  - o 2021 Practice Facility Package Option
  - o Up to 4 USGA HDCP Annual Registration
  - o Free Ride companion only
  - o 25% off all FVR Merch
- Good for 1 year

#### Note that:

- Package credits can be used any time the course is open to the public
- Walk-ins are welcome but all tee time reservations must be made online or via the FVR app
- Cancellations not made w/in 3-hours of tee time will be charged a 9-hole "No Show" credit
- Credits cannot be transferred from original Regular or related Beneficiaries
- All players are responsible for entering their HDCP scores on FVR app
